## PETITIONERS & CORRESPONDENCE

Time Warner Cable – correspondence received in reference to channel additions and/or deletions.

NYS Office of Parks and Recreation – Correspondence received in reference to the recently submitted Certified Local Government (CLG) program's audit for 2013. The Historic Preservation Commission received accolades for the work they have done and Mayor Kaplan thanked Mrs. Dumond for her and the Commission's hard work.

Goldie Hadley – Correspondence received thanking the Village as well as the First Aid Squad and Ellenville Regional Hospital for their assistance during a recent rupture of a water main pipe at Glusker Garden Apartments.

John Lopez – was present tonight to follow up on previous discussions for the use of the Berme Road Softball field for a men's league. Mr. Lopez told board members that he will be able to obtain insurance coverage and donate \$2,500 towards the purchase of a safety net in the outfield. Mayor Kaplan requested a written proposal for the use of the field, a copy of the insurance and it would be necessary for the league to maintain the field.

TJ Briggs – Ellenville First Aid & Rescue Squad – spoke about the negative media attention that the squad has recently received. Mr. Briggs wanted to reassure the Village Board the Squad will be as good if not better after the recent event. Mayor Kaplan, as well as Board members, stated that the Squad is an asset to our community and it is made up of volunteers and everyone appreciates their work.

#### **PUBLIC HEARING**

Dennis Warner – naming an area in the Village in his honor – Mayor Kaplan stated that at this time Mr. Warner's family has requested that no action be taken as this time since they are still in mourning.

Mrs. Dumond gave a brief synopsis of the original naming of Liberty Square and urged board members to remember why it was named as such.

Mayor Kaplan feels that are living history now and we should recognize people that have played an integral part of the community.

Mr. Al Perry spoke about Dennis Warner's legacy and should find somewhere to name after him.

Mr. Brian Schug stated that Dennis Warner affected the community in many ways.

#### **AUDIT REPORT**

Andrew Arias, Cooper Arias, LLP, was before the board tonight to present an overview of the Village's audit ending May 31, 2013.

- Audit opinion on financial statements

Mr. Arias reviewed the General, Water and Sewer Funds with board members and answered questions from the Mayor and Trustees.

#### **POLICE**

The Chief also spoke about the sprinkler line break that recently took place at Glusker Gardens and has met with emergency personnel to discuss procedures. Trustee Lopez complimented the Chief and members of his department for their work that night.

Chief Mattracion also spoke about his department's computer system and the problems they have recently been experiencing.

Mayor Kaplan complimented the new Village Manager, Joseph P. Stoeckeler, Jr. with his work on current projects. Mayor Kaplan stated that the most important issue is the water project. Manager Stoeckeler updated the board on several components on this project.
