Gary Storms – discussed with the board the Village's water and sewer rates. Mayor Kaplan spoke about the reasons behind the necessity of our rates and the hopes the Village has to lowering them again in the future.

MANAGER'S REPORT

Manager Stoeckeler stated that the Tentative 2014/15 Village Budget was given to the Village Clerk with a net increase of 2%.

Personnel Manual – Mayor Kaplan questioned the reasoning behind the half days given on Christmas Eve and New Year's Eve. Treasurer Polkoski responded that when the holidays for President's Day (Lincoln & Washington) were merged into one, the staff elected to take two ½ days in lieu of one of those days. Mayor Kaplan questioned why the staff did not elect for the Friday after Thanksgiving off and Treasurer Polkoski said that that is a staff holiday and was omitted from the revised Personnel

Manual. Mayor Kaplan requested that resolution be given to the Village Manager so the manual can be corrected.

Extension of the Use of Accrued Vacation Time – Manager Stoeckeler recommended that any unused vacation time be extended to two months (July 31).

Safe Routes to School – Preliminary Design – Manager Stoeckeler met with HVEA Engineers who will be doing the preliminary design for this project as well as the Kossar Place sidewalks.
