MOTION AUTHORIZING EXECUTION OF AGREEMENT WITH B&L AND THE NEVELE ENVIRONMENTAL STUDY #04012014-1

Motion by Trustee Lopez, seconded by Deputy Mayor Younger authorizing the Mayor to sign an agreement with Barton & Loguidice on behalf of the Nevele Resort & Spa in the amount of \$6,600.00 for an Environmental Study of our Wastewater Treatment Facilities. This study is required for the application of their gaming licencse by New York State and no funds will be expended by the Village.

REQUEST FROM ERIC CAFARO

Mayor Kaplan recused himself from this discussion since he is personnel friends with Mr. Cafaro and has represented him on legal matters in the past.

Mr. Cafaro was before the board tonight to discuss a piece of property that he will be purchasing on Market and Canal Streets. In order for him to close of the this property (lot #15) he will need an easement from the Village for a block wall that encroaches eight inches onto our property.

Mr. Cafaro discussed with the board his three possible future scenarios for lots #15, #16 & #17.

- 1. Easement or otherwise to remedy block wall approximately 8 inches that are encroaching on Village property.
- 2. Purchase 8 feet across Lots #16 & #17 from the Village.
- 3. Purchase Lots 316 & #17 or purchase Lot #16 and obtain an easement on Lot #18.

Trustee Steinhoff suggested that the Village obtain appraisals for the three lots and have Mr. Cafaro refund the Village for this exependiture. Also discussed was a Lot Line Agreement which in which the owner acknowledges the overhang is there agrees that the property is there but keeps it there, maintains the property forever. Also attorney fees are incurred and the filing fees.

Motion by Trustee Steinhoff, seconded by Deputy Mayor Younger to enter into a Lot Line Agreement with Eric Cafaro to keep the lot line for (83.311-4-15 and 83.311-4-16) as it is and allow him to maintain the overhang as long as he maintains it forever.

Manager Stoeckeler will obtain a price for obtaining an appraisal for Lots #16 & #17.

Discussion ensued in reference to Mr. Cafaro's future plans for this site.

2014/2015 BUDGET WORKSHOP

The proposed 2014/2015 budget presented to the meets the Governor's criteria to keep the property tax increase below 2%.

The Mayor Kaplan and Board of Trustees went line by line to review
