PETITIONERS & CORRESPONDENCE

Todd Jennings, Ellenville Mountain Running Festival 2017, is requesting permission to pitch tents at the Berme Road Park as well as the New Paltz Brewing Company possibly providing beer at the park during the festival. No action was taken since the Village Code does not allow any camping, smoking or drinking on any Village properties or parks.

POLICE

Chief Mattracion reviewed with board members the number of calls his department had received in the past month. It has been an extremely busy month; used AED machines three times to revive overdosed persons. Chief Mattracion showed board members plaques that his department

received from the First Aid & Rescue Squad as well as Ulster County Legislators.

Sgt. Krystal Morse presented retired police dispatcher John Cummings a plaque for his work at the Ellenville Police Department.

Sgt. Krystal Morse also spoke about a weight loss challenge that took place recently and with the money collected purchased a new bike for a young man in our community.

Chief Mattracion reminded the board that there will be a Police Award Ceremony this coming Wednesday hosted by the Ulster County Chiefs Association.

Chief Mattracion also stated that his department is gearing up for Run like the Wind and that three of his officers are resigning.

Manager Stoeckeler further reported that letters have been sent to property owners with vacant storefronts telling about the façade program through UCEDA. He also spoke about outside users fees for water and sewer and suggested an agreement be in place for each account.

Walter Ganga, 64 Warren St spoke to board members about a snow/ice removal bill he received. Mr. Ganga stated that he had shoveled and was asking relief on this bill.

ENGINEER'S REPORT

Don Fletcher, Barton & Loguidice was before the board tonight on the Water Improvement Project on River Street, painting of the North Gully storage tank and the upcoming CDBG second round grant application for Inflow and Infiltration. Mr. Fletcher further spoke about the need to hold a Public Hearing on the grant application, the NY Rising project for the streambanks restoration. Mayor Kaplan requested that Mr. Fletcher measure the east side of Park Street for a sidewalk project.

BUILDING DEPARTMENT

Building Inspector Schug spoke about receiving a letter of interest from Keith York to join the planning board and Mayor Kaplan requested that Mr. York be asked if he would be interested in being an Alternate on the Planning Board and a full time commissioner on the Zoning Board of Appeals.

Mr. Schug reported that he had a request from Bruce & Marie Baxter about the possibility of a Bed and Breakfast on their property. Mr. Schug will review this with the Village Planner and Village Attorney.

Mr. Schug stated that he sent a letter to owner of the clothing bin on Route 209 and Terrace Hill giving them 10 days' notice to remove the dumpster.
