<u>Planned Parenthood</u> – Alexandra Julson from Planned Parenthood was before the Board tonight to discuss the services that are available through Planned Parenthood and discussed how she is having push-back from the Ellenville Central School. Mayor Kaplan suggested that she speaks to the Chief of Police since he is also the President of the School Board. Mayor Kaplan spoke about tonight's neighborhood walk which was at the east end of the Village (Water Falls). Mayor Kaplan would like to open up the falls as a tourist attraction and hopefully have it be the nicest falls anywhere in Ulster County.

POLICE REPORT

BOARD REPORTS

Trustee Steinhoff wanted to thank Manager Stoeckeler for the way the D&M furniture building is looking and wanted to know what was going on with the old JM Original's building. Manager Stoeckeler informed her that the ARC has taken out a building permit for this location and will eventually move their operation there.

Mayor Kaplan wanted the Village Manager to update the Board on the front of the Norbury Building. He stated that the building will be done in two phases. Phase I will be to remove the left and right boards where the posters used to be recessed and stated that this phase is almost completed. Phase II will be to redo the middle and do a simple art deco design.
