# PETITIONERS AND CORRESPONDENCES

<u>Jack Godfrey</u> – Catskill Resort Museum – Was before the Board tonight to present the Catskill Resort Museum and to look for support on this project.

Mayor Kaplan would like to propose a resolution at the next meeting supporting this project.

<u>Ladies Auxiliary</u> - Wrote a letter requesting a donation from the Village.

Mayor Kaplan stated that the Village is not authorized to make donations.

<u>Casey Spoors</u> – Was before the board tonight asking where the Village will be getting the money from for this project and wanted an update on the clean-up site.

#### POLICE REPORTS
